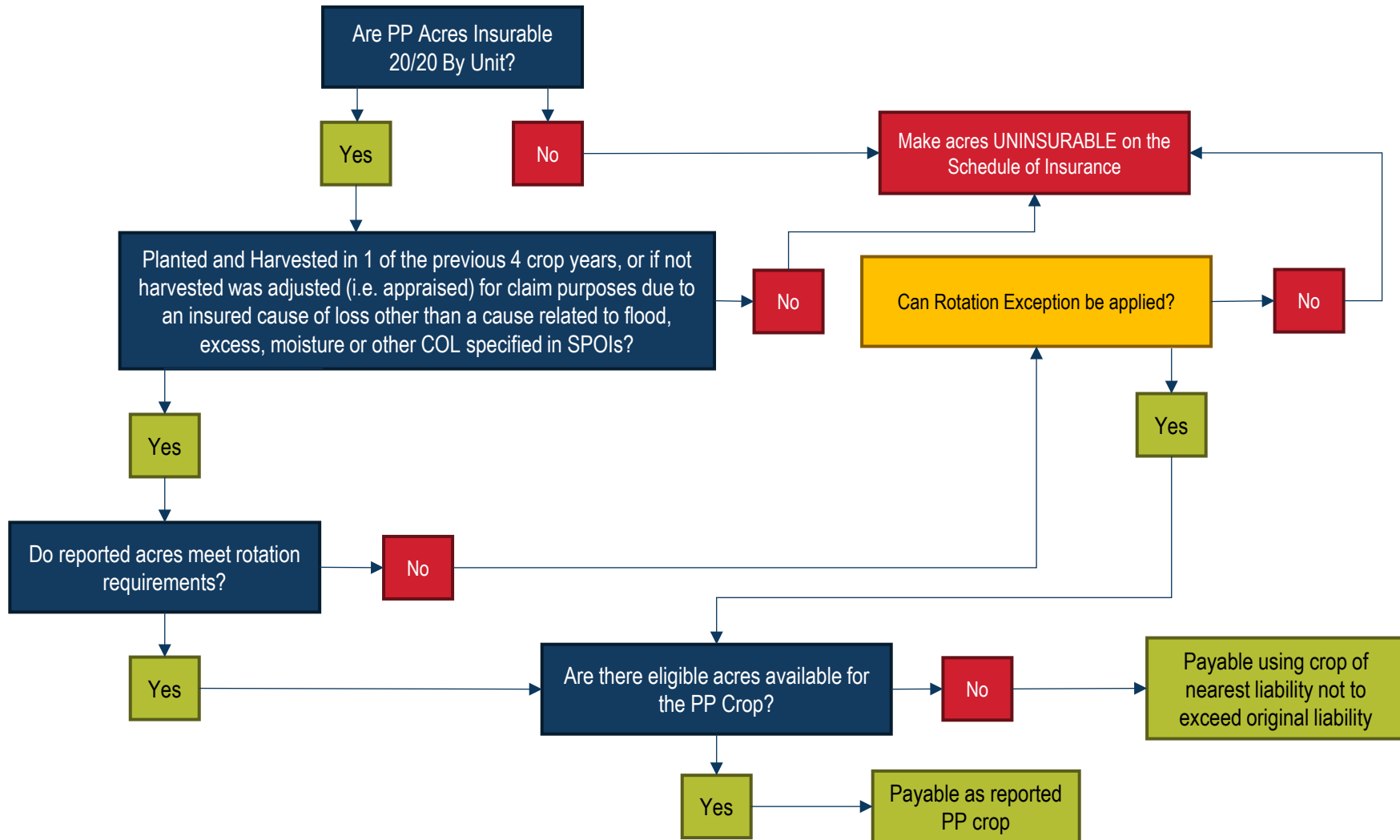


# Prevent Plant (PP) Flowchart

2026 and Succeeding Years

## Insured's Payable Options

1. Not plant a second crop or plant a cover crop and do not harvest for Grain or Seed (receive 100% PP Payment).
2. Plant a second crop for harvest after the late planting period for the PP crop (receive a 35% PP payment\*).  
\*60% of last years approved APH is entered for current year APH
3. Plant a second crop for harvest prior to the late planting period for the PP crop (no PP payment).

# Prevent Plant (PP) Timeline

2026 and Succeeding Years

- ✓ If 1<sup>st</sup> crop is planted **after** LPP due to an insurable cause of loss, the insured can choose not to insure or insure at PP guarantee.
- ✓ If 2<sup>nd</sup> crop is planted **before** the end of the LPP for 2<sup>nd</sup> crop, the insured must insure.
- ✓ If 2<sup>nd</sup> crop is planted **after** LPP for 2<sup>nd</sup> crop due to an insurable cause of loss, the insured can choose to not insure or insure at the PP guarantee.

## Insured's Payable Options

1. Not plant a second crop or plant a cover crop and do not harvest for Grain or Seed (receive 100% PP Payment).
2. Plant a second crop for harvest after the late planting period for the PP crop (receive a 35% PP payment\*).  
\*60% of last years approved APH is entered for current year APH
3. Plant a second crop for harvest prior to the late planting period for the PP crop (no PP payment).

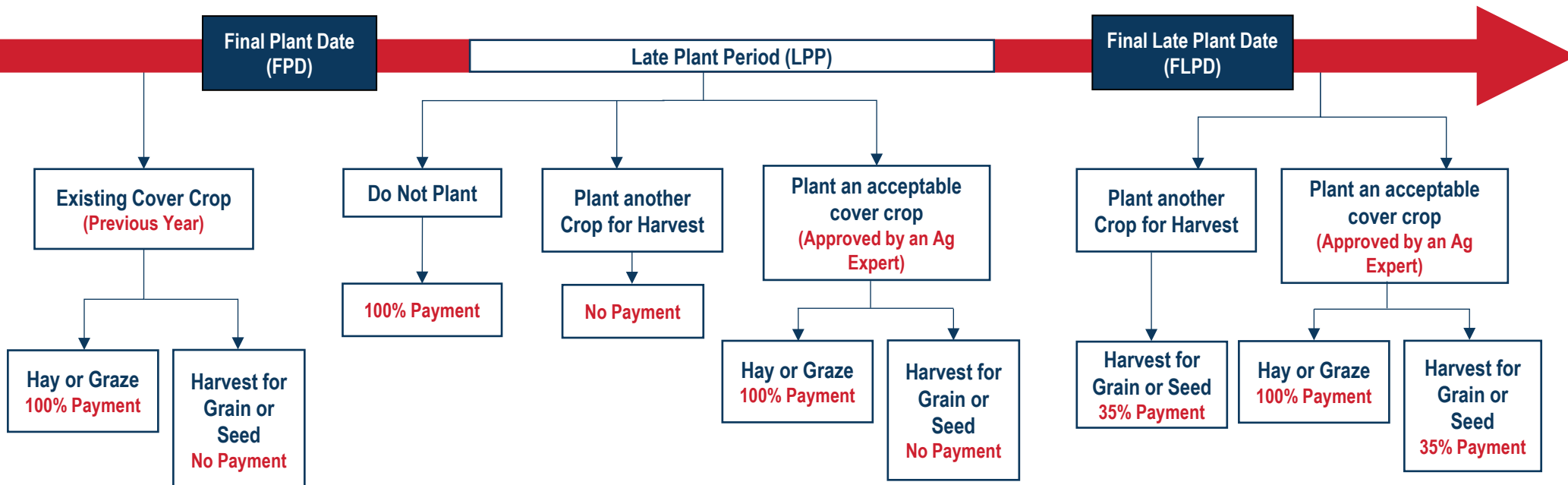
### Plant 1<sup>st</sup> crop
